SUBJECT:

Policy Guidelines on the Use of Incident Command System (ICS) as

an On-Scene Disaster Response and Mechanism

In accordance with the recommendation of the UPLB Security and Safety Office (SSO) under the Office of the Vice Chancellor for Community Affairs (OVCCA), this policy is being issued to provide guidance to all UPLB constituents in managing crisis and disaster emergency situations. The primary objectives of this policy are to prioritize saving lives, ensuring the safety of responders and victims, protecting university property, and stabilizing incidents.

This policy aligns with the key provisions of Republic Act No. 10121, Series of 2010, as well as national policies, specifically:

- National Disaster Risk Reduction and Management Council (NDRRMC) Memorandum No. 04, Series of 2012, which outlines guidelines for the use of ICS.
- 2. NDRRMC Memorandum No. 48, Series of 2015, which focuses on the localization of ICS forms.
- 3. NDRRMC Memorandum Nos. 43 and 44, Series of 2016, which emphasize the need for interoperability among incident management teams and response clusters through emergency operations centers.
- 4. Joint Memorandum of NDRRMC and National Security Council No. 01, Series of 2016, which mandates the use of ICS as an integral component of contingency plan guidelines.












Through previous NDRRMC issuances, the Incident Command System (ICS) has been officially integrated as an on-scene disaster response tool within the Philippine Disaster Risk Reduction and Management (DRRM) system. The ICS has consistently demonstrated its effectiveness in managing potential and actual disaster consequences.

In light of this, all units within UPLB are mandated to establish their own ICS organizational structure. This structure should include principal and alternate officers and members, with complete names and positions. Please use the provided sample format for this purpose.
